

A STUDY OF POLYPREDICATIVE UNITS WITH COMPLEX SUBJECT VERBS

Abstract. This article analyzes complex polypredicative units with a subordinate clause, their emergence with various grammatical means, semantic and structural features of compound sentences that appear in different syntactic functions in relation to the first part, and at the same time, scientific views and conclusions are given on the discovery of new aspects of the complex polypredicative unit with a subordinate clause.

Keywords: compound sentence, organized polypredicative unit with a subordinate clause, compound sentence without a conjunction, subordinate clause, main predicative unit, subordinate predicative unit, syntactic relation, tone

According to the content expressed by the subordinate clause in the main predicative unit, complex polypredicative units with a subordinate clause are divided into the following types.

I. Polypredicative units with complex subordinate clauses expressing the content of the activity-process;

For example: It is interesting that even if Donyor was a believer, we could not talk to him freely and confidently. Ch. Aitmatov

II. Polypredicative units with complex subordinate clauses expressing the content of the event;
For example: It is said that try to stay away from a person who does not return your kindness with loyalty, because nothing but suffering will ever come from them. Navoi

III. Polypredicative units with complex subordinate clauses expressing the content of the subject;

For example: From the mediocrity in his clothing, his arrogant behavior, especially the restlessness in his gaze, I knew that he was not from the police, but from a more serious department. "The dead do not speak" T. Malik

IV. Polypredicative units with complex subordinate clauses expressing the content of the sign;
For example: There are people who, even if no one rejoiced at their birth, the whole country mourns when they die. A. Qahhor

V. Complex polypredicative units with a subordinate clause expressing the content of the object;

For example: 1. But he understood that everything in the house is waiting for him H. Ghulom
2. I can say that if there was someone who occupied my thoughts after my wife's death, it was you. U. Nazarov

VI. Complex polypredicative units with a subordinate clause expressing the content of degree and quantity;

For example: Saida's stomach opened, so much so that, although her limbs were shaking as if she were about to faint, she sat up. A. Qahhor

VII. Complex polypredicative units with a subordinate clause expressing the content of state (manner);

For example: 1. He was so used to Nizamjon that if he was a little late for dinner, he would carry his food on a plate and look for it after him. "Ufq" S.Ahmad 2. It should be done in such



a way that the snake does not know exactly who to bite", the "politburo" who came to the conclusion that it should be done in such a way that the snake does not know exactly who to bite, entrusted Teniz with the task of finding a way to distract. "Murdalar sabihin malay" T.Malik

Based on the analysis of examples, we can say that the subordinate parts of the complex polypredicative unit with a subordinate clause, which explain the content of the reference part in the dominant part, also consist of types of compound sentences expressing different content-relations. Accordingly, we can divide complex polypredicative units with a subordinate clause into the following types.

I. Complex polypredicative unit with a subordinate clause expressing the conditional content:

1. Undoubtedly, if I started talking about this directly, I would be apologizing for the work I was doing. "Ma'suma" T.Malik 2. Bor masalkim, ish yurmas, Sohibi gar bolsakoj. E.Vohidov

II. Polypredicative unit with a complex subordinate clause expressing the content of the unconstrained part:

1. There are times when the heart yearns for love, when you become intoxicated by a single smile or a warm word, even if it is not just a beautiful girl, but a hot one. O.Yakubov 2. There are some words that, although their use is absurd in one religion and language, are not absurd in another religion and language. Biruni

III. Polypredicative unit with a complex subordinate clause expressing the content of the unconstrained part:

Know well that if you hurt a heart that is the focus of Allah, then even if you go to the Kaaba, the reward you received from it will not be able to wash away the sin of the heart that is in pain. "Engkichik jinoyat" T.Malik

IV. A complex polypredicative unit with a subordinate clause expressing the content of the cause:

It is said: "My child, do not go as a guest to just anyone, because it will harm your luxury and charm." "Halovat" T.Malik

V. A complex polypredicative unit with a subordinate clause expressing the content of time:

It is surprising that when Ummatali asks someone about his son, he immediately tells him where he is without thinking about who he is.. "Ufq" S.Ahmad

VI. A complex polypredicative unit with a subordinate clause expressing the content of comparison:

More importantly, this love of Allah is beneficial not only for these two beings and our brothers like them, but also for others. "Odamiylik mulki" T.Malik

Based on the above considerations, we can conclude that the combination of more than one simple sentence and its appearance as a subordinate part forms complex polypredicative units with subordinate clauses.

Complex polypredicative units with subordinate clauses are a separate complex syntactic whole, distinguished both in terms of structure and the content they express.

The scientific study of complex polypredicative units with subordinate clauses helps to correctly solve the problems of the syntax of complex compound sentences in the modern Uzbek literary language.
