In Uzbekistan, women's rights and their role in society are one of the priorities of state policy. The country pays great attention to protecting the rights and interests of women, increasing their socio-political and economic activity.

In recent years, Uzbekistan has adopted a number of important laws to support women. In particular, in 2019, the laws "On Guarantees of Equal Rights and Opportunities for Women and Men" and "On Protection of Women from Harassment and Violence" were adopted. The Women's Committee of Uzbekistan, Gender Equality Commissions, and other specialized bodies are working to ensure women's rights. The government is also implementing social programs, education, and healthcare projects.

A number of changes have been made to the Family Code to strengthen women's rights and ensure gender equality in the family. In particular, new norms have been introduced to prevent violence against women and provide them with social protection.

The Labor Code of Uzbekistan has been amended to protect women's rights to work and ensure the principles of gender equality. The legislation prohibits gender-based discrimination in the workplace and establishes preferential conditions for women.

Article 46 of the Constitution of the Republic of Uzbekistan guarantees equal rights for women and men.

Resolution No. 192 of the Cabinet of Ministers of March 30, 2020 approves the Regulation on the procedure for conducting gender-legal expertise of regulatory legal documents.

Presidential resolutions and decrees establish measures to strengthen guarantees of women's labor rights, support entrepreneurial activity, and provide social support.

These documents are aimed at guaranteeing the personal, political, economic, social and cultural rights of women and serve as the main legal framework for ensuring their equal participation in society .



Uzbekistan has acceded to the main international human rights treaties of the UN, which are aimed at ensuring women's rights and gender equality. In particular, international instruments such as the UN Convention on the Elimination of Discrimination against Women (CEDAW) are an important basis for protecting women's rights in Uzbekistan.

National legislation is formulated in accordance with international standards and treaties, and the state is responsible for ensuring equal rights and opportunities for women, including in the areas of labor, education, healthcare, social protection, and political activism.
